



LIFETIME LIMITED WARRANTY

Installation of New Garage Doors

For the installation of a new garage door, this warranty covers defects in workmanship, for the labor furnished by Big Guy Garage Doors as a part of the installing the new garage door for one (1) year from the date of installation. The garage door manufacturer provides its own separate warranty to you for the door and its parts. This warranty does NOT cover the door or its parts. Big Guy Garage Doors will correct any defective workmanship and, if a part is covered by the manufacturer's warranty, he will repair or replace that defective part, at no charge for the labor for up to one (1) year from the date of installation.

Repairs

Big Guy Garage Door warranty's there springs used for residential against defects in materials and workmanship as follows:

Three (3) years for doors up to eight (8) feet high.

One (1) year for doors over eight (8) feet high.

One (1) year on commercial applications.

For a complete overhaul repair to an existing garage door, this warranty covers any defects in materials or workmanship, including installation, for the new and rebuilt parts furnished by Big Guy Garage Doors as a part of the repair. Big Guy Garage Doors will repair, or if repair is not possible, will replace any defective part or workmanship at no charge for materials.

HOW LONG COVERAGE LASTS

This warranty begins when repairs or any installation is complete. This warranty cannot be transferred. For repairs to an existing garage door, the warranty continues for as long as the original customer owns the garage door. For a new garage door installation and a complete overhaul repair, the labor warranty is for one (1) year from the date of installation or repair. The warranty terminates if the original customer sells or no longer owns the repaired new garage door.

Partial Service Warranty. If this option is selected, the terms are consistent with the terms of the limited warranty, but lasting a period of 90-days beginning on the date of service completion.

WHAT IS NOT COVERED

If anyone other than the authorized Big Guy Garage Door Service Technician performed the original service work on the new or repaired part covered by the warranty, then that part and the labor to repair or replace that part is no longer covered under this warranty. For new garage door installations, see the manufacturer's warranty for what is not covered under its warranty.

This warranty does not cover any materials or workmanship provided by anyone other than the authorized Big Guy Garage Door Service Technician issuing this warranty. This warranty does not cover consequential or incidental damages, such as damage or injury to a person or property because a garage door did not operate properly. Some states do not allow the exclusion or limitation of incidental or consequential damages, so this limitation or exclusion may not apply to you.

This warranty does not cover problems caused by abuse, misuse, civil disturbance or Acts of God and does not cover commercial door installation or repair.

If you have a problem, contact Big Guy Garage Doors who did the repair or installation work for you.

HOW STATE LAWS APPLIES

This warranty gives you specific legal rights, and you may have other rights that may vary from state to state.
